ACCUPLACER Scores from another Institution: We strongly recommend that students take the ACCUPLACER at the NHCC testing center. Students electing to use ACCUPLACER test results from another institution must also submit a NHCC "Transfer Test Score Evaluation" form that has been completed by a staff member at the testing center.
- Make arrangements to take your HESI A2 Admission Assessment. You will need to follow the directions found at www.nhcc.edu/hesi to reserve a test date, register for the HESI A2, and purchase your exam. Your application is not complete until you have taken the HESI A2 Admissions Assessment.

Applicants must meet and understand the following Nursing Program Application Requirements. Carefully read and check off each requirement.
