So What is the Legal Studies/Seminar Course?

Every semester, students visit me to ask questions about the Legal Studies Seminar course, PLEG 2930, which is a course I teach both semesters and during the first summer session. The Legal Studies Seminar is a capstone course. Everything you have learned in your paralegal education comes together in this course. It is designed to be taken in the final semester of your education, so that you can apply what you have learned in an office setting. All students complete a portfolio that includes essays on the paralegal career and ethical situations, a resume and cover letter, revised legal research memos from

Legal Research & Writing I and II, work samples from either student internships or practicum assignments, and six samples of coursework completed within the program as a whole, including at least one PowerPoint presentation.

Students in PLEG 2930 have the option of pursuing the internship tract or the practicum tract within the course. The internship choice requires students to obtain an internship on their own through networking opportunities, cold calling, and research. I offer suggestions to those looking for an internship, if

needed. However, it is up to the student to send in a resume, complete the interview process, and obtain acceptance with the internship host site. Be aware that most internships do not turn into permanent jobs. However, you will be gaining valuable experience for your resume and, hopefully, an excellent reference for your job search.

Practicum students are those students who either have difficulty finding an internship or whose schedule or finances won't permit them to commit to the 150 hour, typically unpaid, internship requirement. The practicum tract requires students to complete assignments similar to those in a law office in the Paralegal Learning Lab. In

addition, practicum students also benefit from hearing the experiences of those completing internships during joint class sessions.

The course consists of two types of classroom activities. We hold joint classes that include internship and practicum students where we discuss topics that relate to

both groups. We also discuss what happens in a law office, so that internship students can benefit from comparing their situations with other internship students. Practicum students benefit from hearing about the office experiences of the internship students. I also frequently bring in speakers on the various topics we discuss in class.

The other type of classroom activity is only for practicum students. During that time, we discuss

various assignments that are similar to assignments students would receive in a law office and students complete the assignments while working in the Paralegal Learning Lab in CBT 101B.

On Friday, November 22, 2013 at 2:30 p.m. in CLA 139, there will be an orientation for students who plan on enrolling in the Spring 2014 session of the Legal Studies Seminar. An email on this was sent out last week. At that time, we'll discuss how to obtain an intern-

ship, I will distribute the packet and syllabus, and I'll answer any questions. Please plan on attending if you registered for the Spring 2014 course. **If you can't make the orientation session, please email me after the session and I will email you the packet.
